Celebrating the Older Americans Act



Every March, Meals on Wheels programs across the country celebrate the 1972 amendment to the Older Americans Act of 1965 that established a national nutrition program for seniors 60 years and older. For more than 50

The Older Americans Act (OAA) is the primary piece of federal legislation supporting the social and nutritional needs of seniors, caregivers and their families.

THE OAA WAS SIGNED INTO LAW IN 1965;

it has been amended and reauthorized nearly 20 times since it was first established in an effort to expand access and availability of social services and support for older adults in the community

OAA services, like congregate and home-delivered meals, aim to serve groups of older adults living in the community with the GREATEST SOCIAL OR ECONOMIC NEED, such as those who:

- have low income;
- are a racial or ethnic minority;
- live in a rural community;
- have limited English proficiency; and/or
- are put at risk of institutionalization

The OAA Nutrition Program is the only federally supported program designed to meet the nutritional and social needs of older adults.

Established under the OAA 50 years ago, in 1972, the TITLE III-C NUTRITION PROGRAM aims to:

- reduce hunger, food insecurity and malnutrition;
- promote socialization; and
- improve the health and well-being of older adults

by assisting them in **GAINING ACCESS TO NUTRITION** and other **DISEASE PREVENTION** and health promotion services and delaying the onset of adverse health conditions

A Message from the Executive Director

We all probably are familiar with the Internal Revenue Service's annual April 15th deadline for filing our income tax returns. It is a reckoning and accounting of our financial activity each year. Meals on Wheels has this same sort of annual assessment.

Meals on Wheels Wake County incorporated as a public charity in North Carolina in 1973 and received tax -exempt status under section 501(c)(3) of the Internal Revenue Code. Even though Meals on Wheels is not required to pay federal taxes, we are required annually to file Form 990 to record both our revenue and expenses with the IRS. In

addition, we are required to make the Form 990 available for public inspection.

Because we operate for the public good, we have other stakeholders together with the IRS. We also conduct an independent financial audit with external accountants to examine our financial records. As a recipient of federal funding through the Older Americans Act that exceeds the \$750,000 threshold, we submit a Single Audit to the Federal Audit Clearinghouse on behalf of the Office of Management and Budget. A Single Audit tests that the financial statements are presented fairly and accurately, the internal controls exist and are followed, and there is compliance for the Older Americans Act program requirements.

The Triangle J Council of Governments Area Agency on Aging also conducts an audit on behalf of the North Carolina Department of Health and Human Services to ensure compliance with the Older Americans Act program requirements, which is also shared with Wake County. Wake County Human Services also audits our programs.

We also annually renew our Charitable Solicitation license with the North Carolina Secretary of State after a review of our fundraising practices and results.

While all of this information is available for inspection, we summarize this information and publish an Annual Report that is available on our website.

We perform all of these reviews and undergo this monitoring to demonstrate that we are providing a public good effectively. Whether you are a participant, a volunteer, or a donor, you can feel confident that Meals on Wheels of Wake County is doing the right things in the right ways.

Protect Seniors from Scams

Many of us are familiar with receiving scam calls. However, many seniors sadly fall victim to predatory scammers and their deceptive tactics. The Social Security Administration Office of the Inspector General urges everyone to be cautious of any contact supposedly from a government agency telling you about a problem you don't recognize and provides the following tips. Real government officials will NEVER:

- -Threaten arrest or legal action against you unless you immediately send money;
- -Promise to increase your benefits or resolve a problem if you pay a fee or move your money into a protected account;
- -Require payment with gift cards, prepaid debit cards, wire transfer, Internet currency, or by mailing cash; or

try to gain your trust by providing fake "documentation," false "evidence," or the name of a real government official.
